InformationDirections from the Brussels Airport (BRU) to Downtown BrusselsPlease see the EUROCONTROL *headquarters information pack* for the address
and how to reach the premises by car, public transport (bus, tram), train, and taxi.

*No special rate agreements are in place between hotels listed in this pack. A list of hotels is available in Attachment 1.

The distance from the BRU to the downtown area is approximately 7.5 miles or 12 km. Taxis with a meter are available in front of the arrival's hall. Licensed taxis have a blue and yellow emblem.

Travelers are advised to avoid unlicensed taxis.

A train to all three main Brussels stations (Nord/Noord, Central/Centrale, and Midi/Zuid) runs from the airport station located at the lower level (-1) of the terminal. When you exit the arrival hall, take the lift or escalator on your right to go down to level -1. Tickets can be purchased at the train station ticket counter. If they are closed, a ticket can be purchased from a vending machine (they only accept Maestro cards). If boarding a train without a ticket, it can be purchased on board, but notify the attendant when getting on the train, to avoid paying a fine.
