Travel Information

Dallas is served by Dallas Fort Worth International (DFW) and Love Field (DAL) airports.

From Dallas Fort Worth International (DFW): The hotel is located 21 miles from DFW. Travel time is approximately 25 minutes and Uber fares are in the \$35 range.

From Love Field (DAL): The hotel is located 12 miles from DAL. Travel time is approximately 15 minutes and Uber fares are in the \$20 range.

Parking is available on premises if you arrive by rental car or your own vehicle. The standard self-park rate is \$11 per day for EFB Users Forum participants. Parking passes reflecting the discounted rate will be distributed for those requiring them.

Once you have arrived, no additional transportation will be required, as all EFB activities will be held at the hotel.
