Context

Over the last few years, the industry has moved to a software release approach mostly driven by suppliers, Original Equipment Manufacturers (OEMs), and Training Device Manufacturers (TDMs). During the 2019 FSEMC Conference in Utrecht, the need to hold a meeting to explore how the software release approach could be better adapted to users' and operators' needs was raised.

Meeting Objectives

The meeting is focused on the process of software releases from TDMs, OEMs, and suppliers to Flight Simulation Training Device (FTD) operators, airlines, and training centers.

Some FSTD user have concerns when a new software release is issued:

- Time involved in a full validation of the software
- Quality and content of associated documentation
- Configuration control of the software release
- Effects on training capabilities or existing regulations

TDMs, OEMs, and suppliers have their share of challenges to meet industry demand.

- High volume of software modifications and fixes to introduce
- Turn Around Time to develop and deliver software modifications and fixes
- Introduction and increased use of a binary format from OEMs and suppliers
- Documentation control and configuration management

The main objectives of this exploratory meeting are to better identify and understand the various challenges for all stakeholders and identify required steps to implement guidelines.

Meeting Participants

We are seeking diverse representation (in number and global/regional coverage) of the different stakeholders in order to capture overall industry challenges and determine collaboration means between TDMs, OEMs, suppliers, and FSTD operators to address such challenges. The meeting is open to the following stakeholders:

- FSTD users, airlines, and training centers
- TDMs and integrators
- Regulatory agencies

- Simulator software suppliers
- Aircraft manufacturers
