## **Meeting Objectives**

### **NDB Subcommittee**

The NDB Subcommittee will review proposals for incorporation into the Navigation Data Base Standard, draft Supplement 22 to ARINC Specification 424.

Some of the issues to be addressed are:

1. Universal Avionics to provide a working paper or discussion paper on Level of Service Flag. The objective is to determine the level of service, if they are on the chart and not authorized, or only to capture the authorized levels of service.
2. Airbus to provide an updated proposal on Initial Missed Approach Leg with Immediate Turn.
3. Universal Avionics accepted the action item review Chapter 4 and update Notes 1 and 2 as appropriate to the non-standard sorting sequence.
4. The Action Team to provide a proposal on the coding of PI Legs.
5. MITRE to provide an update on the XML Schema for ARINC 424-21.
6. Honeywell accepted the Action Item to develop the primer on XML development for the group review.
7. Lufthansa Systems to provide a modernized Chapter 3 to bring the references, relationships, and notes up to date.

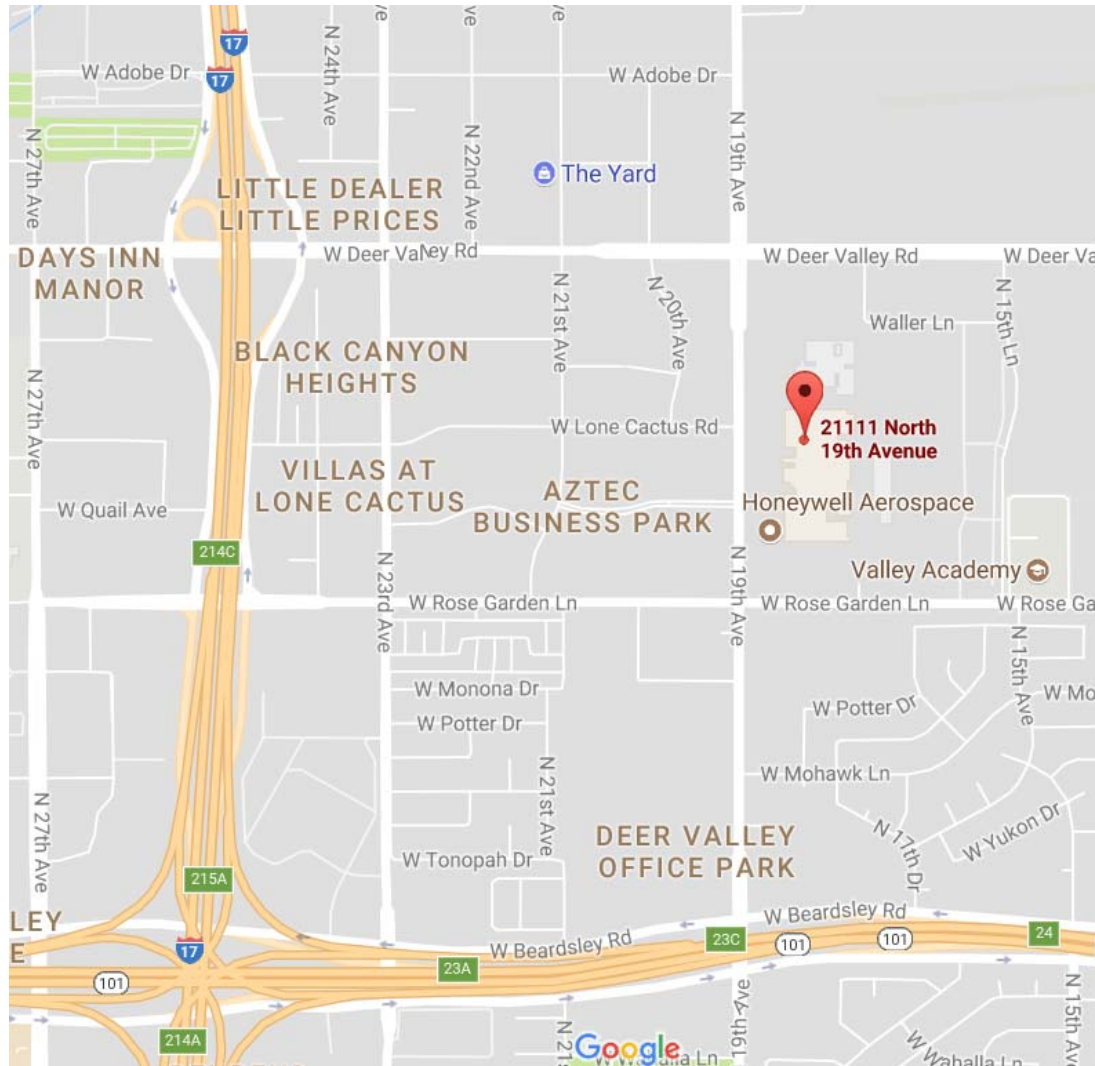


