Travel Information

Please arrange your own ground and air transportation.

The Hilton Orlando Lake Buena Vista is located approximately 15 miles from the Orlando International Airport (MCO). The estimated drive time is 25 minutes.

Various options are available from the airport. A rental car, taxi, or bus service are among your choices. Transportation to the hotel via taxi is approximately \$55.00 without tip. Bus service is available and is approximately \$21.00.

Rental car prices vary depending on your selected provider. There is onsite self-parking which has an associated cost of \$18.00 per day. Valet parking is available and has an associated cost of \$24.00 per day.

Driving directions from the airport to the hotel:

- 1. Depart Jeff Fuqua Blvd (0.9 mi.)
- 2. Take ramp left toward North Exit/Terminal B (0.3 mi.)

- 3. Keep right toward Jeff Fuqua Blvd (0.1 mi.)
- 4. Bear left onto Jeff Fuqua Blvd (1.6 mi.)
- 5. At exit 1B, take ramp right for SR-528-TOLL West toward International Dr/Florida's Turnpike (10.9 mi.)
- 6. Take ramp left for I-4 West toward Tampa (3.7 mi.)
- 7. At exit 68, take ramp right for SR-535 toward Kissimmee/Lake Buena Vista (0.2 mi.)
- 8. Turn right onto SR-535 N (0.3 mi.)
- 9. Turn left onto Hotel Plaza Blvd (0.9 mi.)
- 10. Turn left onto E Buena Vista Dr (0.0 mi.)
- 11. Arrive at E Buena Vista Dr (0.0 mi.)
